In-patient 2/19-2/21/23. Presented to Emergency Room with drenching sweat and fevers up to 100.2. Reports a few episodes of diarrhea and nausea. White blood cells 25.86. Plan for left NT antegrade v retrograde- IR for procedure left antegrade nephrostogram with retrograde pull through and placement of retrograde nephrostomy tube. Findings: occlusion of distal ureter at anastomosis; 16fr retrograde nephrostomy tube replaced. Presently continues with out-patient surveillance.	Chronic	\$61,905.37
